

How to give from the USA?

If you are an American resident, you may be able to maximize your gift through CAF America, a Transnational Giving Europe (TGE) partner by completing the following steps:

1. Please open this [link](#) and fill in the gift form, a gift form must accompany your donation.
2. In the section where it says, "I suggest my gift be used to support:", please tick the box and write the following

Below are the different ways you may transfer your donation to CAF America. Please note that there is a minimum administration fee of \$80 charged by CAF America if you donate below or equal to \$1000. If you give above \$1000, the administration fee will be 8% of your donation. For further information, please refer to the image below (we are currently an eligible organization).
